- 1. Products covered by the Company's warranty come with a written product warranty (the "Product Warranty").
- 2. This limited warranty is valid only in the Taiwan region.
- 3. If any warranty service is needed, the consumer must provide the original receipt or the Product Warranty stamped by the original place of purchase.
- 4. The Company's authorized repair and service station will inspect the Product. If it confirms that the malfunction stems from manufacturing, free repair service will be provided during the warranty period (which starts from the original purchase date). If the product is irreparable with parts, such Product will be replaced with a product of the same model or with similar specifications. For details on the warranty period, please refer to "Product Warranty Period."
- 5. As each Product is customized, a cooling-off period of seven (7) days prescribed by the Consumer Protection Act will not be applicable, and therefore the Product cannot be returned or exchanged. If, however, the Product is damaged upon arrival, the Original Manufacturer will provide a replacement free of charge.
- 6. If the Product Warranty Period has expired, the consumer will need to pay out-ofpocket for parts and repair service fees (the "Repair Fees").
